PBCE Public Water Service Backflow Protector

As of June 25, 2008 Jupiter Utilities will no longer require backflow devices to be installed. Florida Department of Environmental Protection and Florida Department of Health officials have now informed Jupiter Utilities the hookups can resume without the backflow devices. From what we have been told, DEP appears to have every intention of developing a more specific policy or rule for residential back flow preventers in the near future (think the end of July at the earliest to possibly as late as October) State officials may decide to enforce the backflow device installation again. They could start requiring the devices again, from that point on or they could make the ruling retroactive. We have been told it would be very unlikely for the state to require the devices retroactively, but they could, or they could do it from that point on. It was suggested that if you plan on hooking up to Jupiter water now is the time to do it.

Public input on backflow prevention devices:

The following Frequently Asked Questions have been prepared to provide you with some insight into the issue surrounding the backflow protector when hooking up to Jupiter water.

Why has this just come up after hook-ups had already started in PBCE? After reviewing the code, the State of Florida's Department of Environmental Protection (DEP) wrote a letter to the Palm Beach County Health Department, along with all the other Health Departments in the state, and told them not to certify any new installations unless the water utility involved agreed to install the backflow protector device. For Jupiter to resume hook-ups they had to agree to install the device or the Palm Beach County Health Department would not release the health certificates for the last two sections of the water project. What involvement does DEP have and what is this code? Florida's DEP is responsible for protecting the quality of Florida's drinking water as well as it rivers, lakes and wetlands. The code deals with preventing cross-contamination between public water and untreated water. Did this code just go into effect? This code has been in effect for a long time however it was not implemented. Recent events with the water in the City of West Palm Beach may have brought this code to the forefront. Does this affect only Palm Beach Country Estates? No, if this code has to be enforced it will affect the entire state. Several develop-Jupiter water service will I be required to add the backflow protector? Not at this time, Jupiter is not requiring those who already have service to add the protector, but a final decision has not been made yet. What is being done to stop this requirement? There is a lot of opposition to the enforcement of this code. Palm Beach County Utilities is opposed and is trying to fight the requirement. Florida House of Representative Carl J. Domino has written to the Department of Environmental Services requesting more information on the likelihood and necessity of the devices being mandated. South Indian River Water Control District has agreed to have their attorneys contact the State to remove this requirement. If no reversal takes place in two weeks from SIRWCD's June 16th meeting then they will pursue suing the State to change the rule. The Palm Beach County Commission has instructed their lobbyists to fight the requirement. What are my options if I want to hook up water? A Town of Jupiter Utilities representative suggested hooking up now, before the final ruling in July-October. As of June 25th you are not required to install the backflow device, but that may change. We hope that by the time you read this article this issue will be resolved to everyone's satisfaction.

Note: There have been several articles in the local newspapers covering this issue. While they are basically correct they do have some slight inconsistencies in the facts presented. We suggest you keep this in mind when reading any article on this subject.

Message from the President

I would like to introduce myself. My name is Chris Reinhardt and I was born and raised in the Jupiter-Palm Beach Gardens area. My grandparents and

Jog Road

The County advertised the project for bid in the Palm Beach Post on Sunday June 22. The next advertisement will run again Sunday, June 29th, with the mandatory pre-bid meeting for contractors scheduled for July 8, 2008, and bid opening scheduled for July 24, 2008. They expect that construction will begin on or about October 1, 2008, and should take approximately 12-14 months.

Property owners who are adjacent to any portion of the right-of-way for this project will receive certified letters instructing them to remove any encroachments that they might have from the right-of-way; they mailed the letters June 25. Any encroachments in the right-of-way must be removed on or before September 30th, and that's all explained in the letter.

<u>Donald Ross Landowners Association</u> <u>Meeting 5-20-2008</u>

General meeting was called to order at 7:35 p.m., Mike Danchuk, President, called the meeting to order. Board officers Kevin Baker, 1st Vice-President, Lynn Horne, Treasurer and Chris Reinhardt, Secretary Treasurer's Report- Lynn reported there is \$12,512.63 in the operating account and \$7,310.59 in the legal fund. Mike Danchuk stated that we are doing well for the rest of the year. Mike stated that if you have still not paid your dues please do so. Mike asked for a motion to approve the Treasure's report. Motion was approved. Secretary's Report - Minutes of the 3-11-08 were printed in the May newsletter and were available at the meeting. Mike asked for a motion to approve the minutes for the meeting. Motion was approved. Speakers- Brian Miller candidate for District 83 State House of Representatives, introduced himself to the residents and informed residents of his stand on many issues that are important to him. Brian stated that he feels there needs to be a change of priorities in Tallahassee and that the Florida Legislature has a lot of answering to do in terms of budget issues. Brian feels that we are cutting spending on important programs and paying too much on wasteful programs that are not working. Brian was thanked for his appearance and his brevity and was asked to join the meeting. Old Business-Roads Mike reported that SIRWCD has approved a test of Soiltac on a section of road near the SIRWCD main building in Jupiter Farms. Mike also reported that the Soiltac product came in at a much lower price of between \$700 and \$750. Mike stated that if this product works it could be applied to dirt roads in PBCE to keep the dust down. Test should be completed in the next couple of months. Tree Trimming - Mike stated he noticed residents have been heeding the warnings about trimming trees prior to May. Mike stated that according to SWA yard waste at the curb over 6 cubic yards will not be picked up and the resident will have to pay a large premium to have it picked up. Note - SWA will pick up the first 6 cubic yards and tag the remainder to be picked up the following week. Or the resident can hire a private hauler to dispose of the remaining debris sooner. Mike encouraged residents to have all of their trimming done prior to the end of May before the new SWA service change takes effect and prior to hurricane season. Jog Road- Mike stated that the Jog road extension is going to be delayed again. The county has stated they are anticipating the end of the year for the beginning of construction. Mike stated that we may not see construction starting on the Donald Ross side, as the contractor will have the choice of whether to start construction on the Jog road side or Donald Ross side and this construction could take up to a year. Mike stated that there are no plans in the county's 15-year plan of extending Donald Ross west of 69th. He stated also that the residents of PBCE need to be diligent in making sure that Donald Ross never does get extended further west. Park - Chris reported on the status of the park. She stated that on 5-17 more clearing of the park was done. Volunteers used chainsaws to cut down dead pine trees and cut them up into manageable pieces. David Jarrell of David Jarrell Construction brought out his front-end loader and worked many hours to help build a berm and level out the dirt at the park. The berm will be flattened out by Jimmy Specks bobcat and will be ready for the areca palms that will be planted on the south end of the park adjacent to the neighbor's property. Sheri Murray and Sarah Applegate from the Fundraising Committee reported that on June 7th there will be a Casino Party at Sheri and Steven Murray's home to raise money for the playground. Sheri and Sarah stated they are planning many more family fun activities in the future to help raise money for the playground. Mike reported the

Min. Cont. association has spent approximately \$6,000 and the Twisty Pines Playground foundation has paid approximately \$2,300 so far on the site cleanup of the park. Chris reported that residents of PBCE have been working on the cleanup and provided bobcat and front end loader services at reduced rates. She stated the majority of the cost has been in debris removal and hauling away the debris. Tim Brown stated he has ordered areca palms through Tim Wayland of Growers' Choice, which will be planted on the south end of the property. Mike also stated that Bob Berman donated the plants. Mike reported that two neighborhood owned businesses have each sponsored a section of the fence to run along the perimeter of the park. The newest business was Joel Maxwell of Big Picture Solutions, with a donation of \$2,500, Thanks Joel! Mike also reported that Twisty Pines Playground foundation is a nonprofit 501(c)(3) and all donations are tax deductible. Please check out www.twistypinesplayground.org to sponsor components, make a donation or to register to volunteer for the build week of February 25th - March 1st, 2009. Sheri reported that Lisa Janero, with Janero Pools, has offered to donate \$300 to Twisty Pines for every contract signed in PBCE with Janero Pools between now and the build date. If there are any other businesses in the neighborhood that are interested in making a similar pledge based on sales to PBCE residents please contact Sheri Murray at 561-601-1647. Water - Mike stated that at the last SIRWCD meeting it was reported that according to a long standing Florida Department of Environmental Protection regulation that states if you have other sources of water (i.e. pond, well, canal etc.) you are required to put in an additional backup valve that prohibits backflows and contamination in the line from illegal hookups. The Palm Beach County Health Department sent a letter to the Town of Jupiter stating it would not release our latest water lines it was testing until the town agreed to install the additional valves. As a result, the Town of Jupiter, who has not agreed to use these valves, has suspended any new hookups until this situation has been cleared up. Bob Berman stated that it also has not been determined as to whether residents who have already hooked up to the Town of Jupiter water will have to go back and have these valves put on their water lines as well. Mike stated that he would continue to advocate for PBCE regarding this situation. Mike stated all the water lines are completed and awaiting pressure testing in the last section of the neighborhood. Sidewalks - Along 69th, concrete sidewalks will be put in with the Jog road extension from Donald Ross road to 140th. The remainder of sidewalks that will be put in along 69th from 140th to 155th will New business- No new members present. Mike stated that he received an email from Phillip Levenstein from the Health Department requesting a meeting with the residents of PBCE regarding a temporary facility for use in PBCE for administering emergency treatment in the case of Anthrax or other outbreaks in the area. Residents at the meeting agreed to have a speaker come to any future Landowner's meetings to explain this further. Mike stated that Councilman Bob Freeman of the Town of Jupiter recently was reported saving he thought it would be a good idea to have a Turnpike interchange at Donald Ross road near I-95. Currently the proposed site of a new interchange is north of Hood Road. Mike stated the interchange at Donald Ross Road would be something the Landowner's Association will fight, because it would impact our neighborhood as well as others nearby too greatly. Mike reported the top 10 concerns of the residents who have paid their dues recently. The number one concern was reported as the roads. Chris also stated that per her conversations with other parents in the neighborhood, that there is a great concern regarding teenage drivers speeding through the neighborhood and skidding around corners after school. The parents are concerned because this is the same time kids are being let off the school busses and are walking home on the side of the roads. The Palm Beach County Sheriff's office Min. Cont. pg 5

Min. Cont. has been contacted and they will begin to have a greater presence in the neighborhood in the afternoons after school is let out. Neighbors brought concerns regarding illegal dumping of yard debris near canals and vacant properties. Mike stated this is a crime and should be reported to SWA and they will investigate it. Lynn Horne stated the cost to print out the newsletter is \$1,400 and would like to know how many people read the newsletter and requested asking residents to go to the www.mypbce.org site and report that they do read the newsletter. Mike Danchuk stated that the newsletter is currently paying for itself with the ads that we have been selling. Mike stated that he would like to have a newsstand at the front of the neighborhood for residents to get information regarding newsletters, and any other important information regarding PBCE. President's Award Mike presented an award to Daniela Russell for her service to the Donald Ross Landowners Association. Even though she is no longer a board member, Daniela has continued to assist the association in financial matters including completing our taxes and assisting Lynn Horne in her transition in becoming Treasurer. Thanks Daniela! Mike stated this was his last meeting as President of the Association and would like to thank everyone for their support. Mike stated he hopes to see the Association continue as a voluntary association. Mike states that he intends to keep working on a voluntary clubhouse on the corner of 69th and Donald Ross Rd. and will continue to work on this with zoning and the residents. Mike states that he also hopes to make a nice front entrance as a part of the clubhouse plan. Mike stated that he hopes to not see any more OGEM roads in the community and that these roads are not lasting as long as they should and the residents of this community will live here longer than these roads will last. 




