Message from the President

In my first "Message from the President", you should know right away that the hand-off between Chris Reinhardt and myself has been smooth and that the mission of our landowners' association has not changed. Since I first joined the board in May 1999, we have built

& rebuilt the front entrance and established our community park through generous donations of time and money. Every day, as horses trot past my window, I am reminded that the essential character of our neighborhood has not changed and the quality of life has

improved. Palm Beach Country Estates is still a great place to raise a family, live close to nature, and avoid being told by a bunch of condo-commandos what you can and can't do on your own property.

The strength of our organization comes from gathering together to speak as one voice to county, state, and federal officials about issues important to us such as the irrationally-high price of homeowner's insurance. Moderating our Facebook group, Palm Beach Country Estates Neighbors, I see daily examples of the power of many voices meeting in our community forum to share our collective wisdom. Start your own conversation by posting a question or feel free to "Friend" me, Kevin Baker, and send me direct messages about neighborhood issues or how you would like to get involved.

Back in July 2013, Gov. Rick Scott vetoed State Rep. Pat Rooney's unanimously passed local bill HB 855, submitted at the request of South Indian River Water Control District (SIRWCD), which would have allowed SIRWCD to "improve" the park and finish building the remaining elements: pavilion, basketball and racquetball courts. The Governor claimed that any

> park improvements should be done by the county instead of SIRWCD. Rooney has revived the local bill again this year as HB 1171 to allow SIRWCD to "construct improvements upon" our park as long as "Palm Beach County declines in writing to

do so." When this bill advances out of the Local & Federal Affairs Committee and clears the entire FL legislature, I will let everyone know when to call Gov. Scott to push for his signature.

At our annual meeting on Tuesday May 20, 2014, elections will be held for President, 1st Vice President, and Secretary. If you wish to run for a board position, please call one of the existing board members so that your name can be added to the ballot. I am fortunate to have a very strong team of volunteer board members. So while I have not previously sought the presidency, I will present myself for election to that post and nominate Carol-Sue Ryan for 1st VP, and Ellen Meehan for Secretary. We will have special guest speaker Carl Domino. Please come.

Regular Meeting March 27th, 2014

The regular meeting was held on the fourth Thursday this month because of the school being closed due to spring break. It



reported that the was District's Family Day was a huge success! There were almost 750 landowners who showed up to enjoy some time with their neighbors with some really good Sonny's BBQ while listening to a great band. We had several new vendors there this year also.

Paving projects are almost complete and have come in slightly under budget.

The attorney reported that the Governor's office isn't happy with our latest bill presented to allow improvements to our community park in PBCE. The Governor's objection is that he feels parks should be the responsibility of the County first. With the current bills wording and the way the Governor has expressed his objection, if this bill gets vetoed, the attorney feels we will be able to proceed with our desired improvements if we don't get help from the County.

The other big item of the evening was a request from a developer who wants to use the SIRWCD canal right of way to bring sewer and water to a proposed RV park on the north side of Indiantown Rd. Much debate and discussion was had on the matter.

I attended a recent safety meeting held with the district employees and to also celebrate the 15th year at SIRWCD of Arie Raz. An interesting topic presented was that SIRWCD has a drop off tank for used oil that landowners are encouraged to use. Safety items that landowners can help with were brought up. First and foremost were kids around the large equipment. Everyone like to watch the big

Guest Speekers:

PBSO Security Report: The sheriff's office presented their update to the PBCE community. There has been three home burglaries in PBCE since the last meeting and incidents of vandalism. The pillowcase burglars are still active throughout Florida and tend to hit houses in the middle of the work day. If someone knocks on your door with a fishy story, dismiss them and contact the sheriff's department.

Guest Speaker: Karen Clarke from the Tax Collector's Office made a presentation on the Real ID program. The Tax Collectors' offices in the State of Florida are now responsible for all services previously provided by the DMV. Currently, when you receive a new license from the Department, it is a Real ID. This program is the reason why individuals must present extensive documentation at the tax collector's office, including birth certificate or passport, a social security card and proof of residence.

The REAL ID program is the Department of Homeland Security effort to improve the integrity and security of state-issued driver licenses and ID cards.

All citizens and residents of Florida will be required to be in compliance with this program. If you recently renewed your license online, your license is not in REAL ID compliance if it does not have a gold star in the top right corner. Residents under the age of 50 are supposed to be in compliance by December 2014. However, enforcement may be delayed a year. Residents over the age of 50 should be in compliance by December 2017. You can go to the tax collector's website for further information: www.pbctax.com.

Treasury Report: The association has \$9,837 in the operating account and \$10,787 in the legal account.

machines do their work, but the can be very dangerous, particularly the mowing equipment. Please keep



your kids at a safe distance from all machinery. Loose dogs also present an additional worry for the equipment operators. These machines require a lot of attention to operate safely and properly and the operators don't need the additional distraction of a dog running around the equipment and certainly don't want your animals to get hurt.


The operators were also briefed on proper accounting for the equipment's hours. Each piece of equipment is tracked for the exact amount of hours used in each community. This information is used to fairly assess landowners for Palm Beach Country Estates and Jupiter Farms for the needed services.

Old Business

Neighborhood Watch: The COPs volunteers continue to be active and visible patrolling the neighborhood. Overall incidents of crime in PBCE



still remain relatively low but there are still those few cases so use caution and protect your property. Residents are encouraged to directly call the sheriff's department if they witness any suspicious activity. Do not wait and try to contact the local COPS neighborhood watch.

Roundabouts: There continue to be a few accidents at the traffic circle roundabouts on Donald Ross. Remember that roundabouts are much like 4-way stops: the first vehicle to reach the circle has the right of way but must yield to vehicles already in the circle. You do not have to stop if there is no traffic in the vicinity.

SIRWCD: Call Mike Dillon with any road maintenance questions or issues. Be aware of the mowing and grading equipment on our roads. The operators will turn off equipment if horses or small children are nearby, so do not let children get close to the maintenance equipment. SIRWCD is hosting their 22nd annual Landowners Family Day at Jupiter Farms on March 16 and all residents of PBCE are encouraged to attend.

Park: The park continues to be used by many residents. The Dwyer Band held a rummage sale at the park.

Facebook: Residents of PBCE continue to be active on our Facebook group, Palm Beach Country Estates Neighbors, with sharing of useful information including lost and found pets.

Fire Station: We are still talking to the fire department to find a way to get more of PBCE within 5 miles of a fire station. The fire chief did a drive through SFWMD locked gates along the C-18 canal to see how much of the neighborhood was within the 5 mile insurance range of Fire Station #19. Part of this drive is on grass so we need a small section of the canal shell-rocked by SFWMD while they are currently in there with their heavy equipment.

DRLA Charter: We are trying to change the Donald Ross Landowners Association charter to become a non-taxed organization.

Front Entrance: We're still looking at strengthening the lighting at the front entrance which can fail in heavy rain. One option being considered is low-voltage

LED lighting which might be a good alternative.

Volunteers: We're still looking for volunteers to be our webmaster, newsletter editor, or event organizor.

New Business

Great American Cleanup: In coordination with the International cleanup program, we will have a neighborhood cleanup here in PBCE on Saturday, April 12. We will send out emails and post signs advertising the event.

Annual Meeting: Our next meeting is our Annual Meeting on the 3rd Tuesday of May. We plan to have guest speaker Carl Domino, and we will have our election of officers Meeting was adjourned 8:35



particularly in comparison with other nearby neighborhoods. There have been no new pillowcase burglaries, just a few petty crimes, vehicle burglaries, and some van-



dalism. Residents are advised not to leave important outgoing mail in your mailbox due to occasional mailbox break-ins and thefts.

Board Report: Chris Reinhardt tendered her resignation as DRLA President on December 22, 2013. We thank her for her many years on the Board and everything she as done for PBCE. With the resignation, Kevin Baker (1st VP) became acting president The Board met in January and appointed Kevin Baker as the President, Carol-Sue Ryan has been appointed 1st Vice President and Jason McFarland has been appointed the position of 2nd Vice President, all effective January 2014.

Treasury Report: We ended 2013 with about \$20,000: \$10,500 in the operating account and \$9,600 in the legal account.

Secretary Report: The minutes from the November 2013 meeting were approved as written.

Old Business:

Neighborhood Watch: The COPS program continues to operate successfully and regularly patrol the neighborhood. Thank you to the new volunteers who were recently trained; we are always looking for additional volunteers.

SIRWCD: Mike Danchuk and Mike Ryan were re-elected to serve on the SIRWCD Board and Mike Danchuk remains President. Some of the new road pavings in PBCE have begun this week. Since the paving of roads is so expensive, SIRWCD has increasing the percentage of votes needed for road petitions. Mike Ryan is looking into having a Dedicated Dirt Road Referendum which would require 100% of a street's residents to approve paving.

C18 Canal and Vegetation: There is an effort being made to preserve the natural vegetation on the C18 canal. The Army Corps that maintains the drainage normally removes all the Australian Pines and the residents along 89th are asking to keep their vegetation since it is so far from the banks of the canals.

PBCE Park: We have restocked the informal doggie bag dispensers at the Park. SIRWCD continues to work with the legislature and governor to get approval

to allow SIRWCD to fund improvements to the park. We hope to get this approved this year.

Facebook: Join our facebook group for communication with other PBCE residents: palm beach country estates neighbors.

Fire Station/Insurance: We continue to work with the fire department looking for ways to put PBCE within 5 miles of a fire station to improve our ISO rating and lower insurance.

DRLA: We are taking action on changing the way this Donald Ross Landowners Association is incorporated and filing as a non-profit organization.

Front Entrance: We are looking at improving the lighting maintenance at the front entrance. We also are purchasing a new "announcements" sign to replace the last one that was runover and destroyed.

New Business:

Volunteers Needed: We are looking for a volunteer to take over as the new Webmaster for our website MYPBCE since the current webmaster has moved away. We are also looking for a neighbor to be our Newsletter Editor. Volunteers are also needed to help coordinate community events and another community cleanup. The Ryans volunteered to organize the Great American Cleanup.

Jog Road: A resident inquired as to the number of accidents at the jog road roundabout. Please drive carefully and yield to traffic in the roundabout.

Meeting was adjourned 8:20pm.

Sandhill Cranes

It's that time of year again.
The Sandhill Cranes and their babies are visiting our neighborhood.

There is a pair of adults and their two twin fuzzy babies visiting houses on 69th Drive. Please be alert and stop for the cranes when they cross the road.

The Florida Sandhill Crane is listed as endangered, primarily due to habitat loss. They are protected under state and federal law. The Florida Sandhill Crane is a subspecies of the North American Sandhill Crane. Florida Sandhill Cranes are year round residents where as the North American Sandhill Cranes will migrate here for the winter. These cranes are omnivorous and will eat things like seeds, worms, insects, lizards, snakes and mice. They will also eat shelled corn and commercially purchased bird seed from the ground and from feeders. Sandhill Cranes seem little afraid of human or car approach. They can't take off and fly from a standing position, so cars must slow down or stop to let them cross the road. To our west, our community borders a protected Sandhill Crane nesting area. Nesting begins in December to early March. Females typically lay one or two eggs, with incubation lasting 29 - 32 days. These birds can live up to 20 years and mate for life. They are part of our community and it's up to us to protect them.

PBC Tax Collectors Office Update, May 2014

REAL ID Deadline Closer

The clock continues to tick on the first REAL ID deadline. That's because of a law passed by Congress after the 9/11 terrorist attacks on our country. If you were born after December 1, 1964, you have just 7 months until the December 1, 2014 deadline. Everyone else has until December 1, 2017.

How do you know if you have a REAL ID compliant driver license or ID card? Check to see if there is a star in the upper right hand corner. If so,

You must be REALOID'd by:			
Dec. 1, 2014	Dec. 1, 2017		
if you were born AFTER Dec. 1, 1964	if you were born BEFORE Dec. 1, 1964		

you have a REAL ID. If there's no star, you'll need to get one.

To get your REAL ID, the Department of Homeland Security requires you come in person with specific documents proving birth, social security and residence. A list of approved documents is posted at www.pbctax.com. Without these documents, we cannot issue a REAL ID license or ID card.

The best way to avoid waiting is to schedule an appointment for driver license service at www.pbctax.com. Once you get to our counter, the average transaction time for a REAL ID is 16 minutes.

Homeland Security has announced a phased-in enforcement schedule. Full enforcement will begin no sooner than 2016. That's when REAL ID will be required to board a commercial plane or enter a federal building.

Our offices will be closed on Monday, May 26 to observe Memorial Day. On this national holiday, we honor the brave men and women that gave their lives in service to our country. We also remember our active duty troops abroad and pray for their safe return.


