OFFICERS PRESENT: President Ken Trapasso, 1st Vice-President Tim Brown, 2nd Vice-President Jason McFarland, Treasurer Bob Schneider, & Secretary Bob Berman

Approximately 10 landowners were also present and cookies were served.

PLEDGE OF ALLEGIANCE

Ken Trapasso stated that the meeting is recorded to ensure accuracy of the minutes. President Trapasso stated that this July meeting is usually lightly attended due to summer vacations and that is why no special speaker was scheduled. **PBSO REPORT:** Deputy Russell reported that there has been very little crime in Palm Beach Country Estates as compared to other north county neighborhoods. There was one vehicle burglary due to unlocked vehicle. There were three deputies present and they gave some frig magnets to be distributed reminding property owners to keep their property secure. They thanked the COP volunteers for making a difference in the community.

TREASURER'S REPORT: STreasurer Bob Schneider gave the treasurers report. Balance in the General Fund is \$22,215.25 and there is \$11,995.09 in the legal fund. Motion made and seconded to approve the Treasurers Report and the motion passed unanimously.

SECRETARY'S REPORT: Secretary Bob Berman presented the minutes from the Annual Meeting May 16, 2017. Motion made and seconded to approve the minutes and the motion passed unanimously.

N. and also 75th Ave. N is in the final design phase from FPL and should be installed soon. The Palm Beach Country Estates Landowners Association has been working closely with the South Indian River Water Control District to aggressively attempt to keep the swales and sidewalks along 69th Drive N. clear of trash and debris. Landowners are asked to be careful when disposing of lawn debris to place it in a location that does not block the roadway or the sidewalks.







MARGARET BERMAN MEMORIAL PARK UPDATE

Permits have been applied for to add a water supply including a drinking fountain at the park. Additionally, electric service will be provided to the main pavilion for convenience and for use with community events. The park hours are from dawn to dark so no additional lighting will be installed other than motion-detecting security lights for video monitoring of park area violators. Park benches are being ordered for the two smaller pavilions. Now that the park is completed the emphasis will be on maintenance including adherence to the rules of the park. The required chain link fence surrounding the park is in constant need of maintenance due to the increase use of the park. There have too many reports and incidents of landown-

ers not keeping their pets on leashes and/ or not cleaning up after the pet in the park area. Garbage bags are provided for any form of litter including pet litter. The park is "Pack-In/Pack-Out". Please remember to take any trash with you when you leave the park. As a reminder, the park now has 24 hour video surveillance and can be used to determine when violations of the rules or misuse of the park occurs. The park is a great asset to Palm Beach Country Estates and is used by families and landowners of all ages. Please help keep the Margaret Berman Memorial Park a clean and beautiful area for all PBCE landowners to enjoy.

TRAFFIC CALMING STUDY INITIATED

With the cooperation of the District One County Commissioners office and the Palm Beach County Engineering Dept. a traffic calming study has been initiated in response from the numerous complaints from landowners regarding speeding on the main roadways but especially 69th Drive. The Palm Beach County Sheriff has also been responsive in providing additional enforcement when their duty schedule permits. Landowners are reminded to abide by the posted speed limits and also to be careful to stop and yield where posted. Enclosed in this mailing is an information brochure regarding roundabouts. There have been too many accidents and too many "near misses" at the roundabout at the corner of Donald

Ross Road and 69th Drive. All of these have been caused by drivers not observing the correct procedure entering and using the roundabouts. Please review the brochure.



ATV and GOLF CART RESTRICTIONS

The Palm Beach County Sheriff Dept has reminded us again that ATV and Golf Carts are prohibited on any of the roadways in Palm Beach Country Estates. This includes Golf Carts that are considered "street legal". To meet the criteria established by Palm Beach County for the use of Golf Carts in the community BOTH the carts AND the streets need to be determined to be legal. The streets in PBCE (paved and dirt) DO NOT meet the criteria for the use of Golf Carts. The Board of Directors of the Palm Beach Country Estates Landowners Association supports the legal use of Golf Carts in the community and is working with the District County Commissioner in an attempt to make Golf Carts legal in PBCE. However, PBSO has stated that although it is not a priority, the illegal use of ATV's and Golf Carts can result in the issuance of a ticket with a fine up to \$500 or even result in confiscation of the vehicle. PBSO has also stated that the current leadership for this District 3 where we are located has adopted a "no warning" policy which means that if you are caught, the local deputy is required to issue a ticket. A brochure is included in the mailing detailing the restrictions regarding the use of ATV's and Golf Carts in PBCE.



BICYCLE RULES and REGULATIONS

The use of bicycles as transportation around Palm Beach Country Estates is strongly encouraged. However there have been increased complaints regarding the proper operation of



bicycles. Bicycles must adhere to the same rules as motor vehicles when it comes to operations on roadways. Bicycles may use the sidewalk/pathway but pedestrians have the right-of-way over bicycles. Enclosed with this newsletter is a brochure detailing the laws and rules for the operation of bicycles. Please review the brochure to insure that you are operating your bicycle safely.

LOCK YOUR CAR & SECURE VALUABLES OUT OF SIGHT

The Palm Beach County Sheriff (PBSO) Dept has reported a significant increase in Vehicle Burglaries in the county. Although there has been very few in Palm Beach Country Estates, PBSO has asked the local COP (Community Observer Patrol) volunteers and the landown-

ers association to distribute information as a reminder to landowners. Included in this mailing is a brochure provided by PBSO to help landowners prevent vehicle burglaries. ALL of the cases



of vehicle burglaries in PBCE have been instances of unlocked vehicles and/or valuables left in plain sight. Your local COP's also have refrigerator reminder magnets that were donated by PBSO for any landowner who requests them. Please feel free to flag down one of the local COP's on patrol and request the magnet.

Nice to see my repeated ballot layout complaints were finally addressed by the SIRWCD attorneys. Also, back in 2009, 18 residents failed to sign their ballot and their votes were not counted either. COP VOLUNTEERS DESPERATELY NEEDED

Due to recent resignations, the COP program for Palm Beach Country Estates is in desperate need of additional volunteers. The Citizen Observer Patrol program is a part of the Palm Beach County Sheriff Department. PBSO provides the training, uniforms, vehicles for our use and the fuel and maintenance for the vehicles. In return, PBSO asks that we patrol at least 100 hours per month for each of the vehicles. Palm Beach Country Estates has three (3) assigned vehicles. There are two Ford

Focus' and one Ford Escape. Volunteers are asked to provide at least 12 hours of volunteer time each month and attend one monthly meeting. This is a "see and be seen" program. Just the presence of the COP vehicle patrols within the PBCE community over the past 7 years has very significantly reduced the incidents of crime and mischief in the community. Volunteers can choose anytime at all to patrol 7 days a week, 24 hours a day. To volunteer for the program or to obtain additional information, please contact the PBSO volunteer services division at 433-2003 and tell them that you are interested in volunteering for the Palm Beach Country Estates COP program.

- Was instrumental in getting potable water lines installed in PBCE as well as obtaining the necessary rights-of-way to pave the main arterial roadways that are now owned and maintained by Palm Beach County (69th Dr, 150th, 155th, etc).
- Believes that landowners should be able to decide on whether or not they want improvements in their community by a majority vote system. This is the simple system that was in place for 30+ years before the current Board changed it to require a 90% approval to get anything done, effectively making it impossible to ever make any improvements in our area.
- Believes it is unfair that Jupiter Farms residents, by outnumbering PBCE residents 5 to 1, are essentially able to control the
 District and make decisions that aren't necessarily in the best interest of all landowners. PBCE and Jupiter Farms are
 fundamentally different. They should have their own elected Supervisors who can effectively represent them. Ideally, the
 District should be split (east/west of the C-18 canal) to best represent the residents of each area.
- Agrees with outgoing Board member Michael Ryan's sentiment in his resignation letter where he describes the SIRWCD Board of the last two years as a "full-blown circus". It is time to restore some sanity and order to the Board.

VOTE FOR BOB BERMAN to bring common sense, good judgment, and balance back to the Board of Supervisors for SIRWCD



PLEASE DO NOT VOTE FOR JOHN JONES

- Aside from being a landowner, Jones has no real experience or qualifications for the Board position.
- Believes it is fair that any neighborhood improvements need an overwhelming 90% majority approval (which is a <u>ridiculous</u> requirement).
- Despite being a PBCE resident, he is being endorsed by a Jupiter Farms residents' group.
- Believes it is okay for Jupiter Farms residents to elect a Supervisor that is supposed to represent the area East of the C-18 canal.
- Despite being positioned as an "incumbent", Jones was only recently appointed (not elected by landowners) 2 months ago by the Board that was described by resigning Supervisor Michael Ryan as a "full blown circus". The Board did this to give an advantage to their preferred candidate. With an impending election coming up, this should not have been done.
- DO NOT let this "circus" Board of SIRWCD and Jupiter Farms landowners make important decisions for residents of Palm Beach Country Estates.
