

POTABLE WATER DEADLINE

IMPORTANT MESSAGE REGARDING POTABLE WATER FOR THOSE WHO HAVE NOT HOOKED UP!!! LANDOWNERS ARE ENCOURAGED TO HOOK-UP IMMEDIATELY BUT NO LATER THAN June 20, 2018.

The SIRWCD entered into an Agreement with the Town of Jupiter to provide water service to Palm Beach Country Estates on June 21, 2005, and had negotiated a reduced hookup rate for landowners who wished to connect to the system.

This reduced rate is set to expire at the end of June 2018.

The Agreement between the Town and the District provides financing incentives to Palm Beach Country Estates residents to hook up to the system. The current hookup fees are the original fees negotiated by the District in 2005. For 3/4 in. meter service, the fee is \$3,911.28, and for 1 in. meter service it is \$9,387.05. These are substantially less than Jupiter's current schedule of fees, which are \$5,290.08 for 3/4 in. service and \$12,735.20 for 1 in. service. These new rates go into effect later this year. And future rates will continue to increase. Palm Beach Country Estates residents may pay this *Potable Water Deadline Continued on Page 2*

reduced hookup fee up-front if they wish or may finance the hookup fee through the Town of Jupiter. The Town is offering a 20-year term at 5.5% resulting in an annual assessment, including collection costs, of approximately \$349.00 for a 3/4" meter service and \$837.00 for a 1" meter service. The only out-of-pocket expenses for a landowner to hook-up to the potable water are a deposit and application fee and the costs of running the water line to the house. In most cases that is less than \$1,000.

Written Request

The written request to run for office must declare the Office the candidate is seeking. The request should also attest that the resident is current with their 2018 dues as well as having been paid members for the past two years. They must also indicate that they have attended 6 regular meetings in the past 2 years.

Note: The Board is following the By-Laws as adopted on November 14th, 2017. Since this is the first year of the changes to the Election of Officers procedure, after the 2018 election the Board will review the process and requirements and determine if any changes need to be made to the By-Laws.

NEW VOLUNTEERS NEEDED FOR COP

Due to recent resignations, the COP (Citizen Observer Patrol) program in Palm Beach Country Estates is desperately in need of addi-



tional volunteers. The COP program is part of the Palm Beach County Sheriff Department. PBSO provides the training, uniforms, vehicles, fuel and maintenance for the vehicles. In return, PBSO asks that we provide enough volunteers to patrol at least 100 hours a month for each of the vehicles. Palm Beach Country Estates previously had three (3) vehicles assigned to this area. However, there are now only two (2) because of the lack of use. There is one Ford Focus and one Ford Escape. Volunteers are asked to provide at least 12 hours of volunteer time each month and attend a monthly meeting. This is a "see and be seen" program. Just the presence of the COP vehicle patrols with in the Palm Beach Country Estates community over the past 9 years has very significantly reduced the incidents of crime and mischief in the community. Volunteers can choose anytime at all to patrol. The cars are available 24 hours a day, 7 days a week for patrol use. To volunteer for the program or to obtain additional information, please contact PBSO volunteer services division at 561-433-2003 and tell them that you are interested in volunteering for the Palm Beach Country Estates area program. You can volunteer as a driver or as just an observer. Please help with this very important community program.

PBCE Landowners Meeting Minutes

January 9, 2018 7:30 PM OFFICERS PRESENT: President

Ken Trapasso, 1st Vice-President Tim Brown, 2nd Vice-President Jason McFarland, Secretary Bob Berman & Treasurer Bob Schneider.



21 landowners were also pres-

ent and cookies were served. Meeting started with Pledge of Allegiance. Bob Berman stated that the meeting is recorded only to insure accuracy of the minutes and landowners needed to sign in to be considered present at the meeting. A landowner presented to the Association a letter outlining his concerns with the changes made to newly amended bylaws. The Board accepted the letter and will review his concerns. Stephanie Duncan gave a detailed report on the results of the 5 month effort to revise the bylaws including input from as many past officers and landowners as possible. The revised bylaws were unanimously adopted by the Board of Directors and are published on the association's web site.

PBSO REPORT: PBSO Deputy Russell reported there were a couple of vehicle burglaries due to unlocked vehicles. He warned about the seasonal increase in thefts and burglaries and that the Sheriff has directed zero tolerance for the operation of golf carts, ATVs, and motorbikes. He also

recommended more street lighting. Deputy Russell discussed the correct method to complain about actions by a Deputy.

sirwcd report: Mike Dillon from SIRWCD gave a detailed report about activities of the District and answered questions from landowners. The 19th plan for road paving should begin in May. The District will be cleaning outfall easements south from 150th and north from 159th. Mr. Dillon described the culvert replacement program.

TREASURER'S REPORT: Treasurer Schneider reported approx. \$8,000 had been received so far for 2018 dues and no new expenses.

SECRETARY'S REPORT: Secretary Bob Berman reported the minutes from the Nov 14, 2017 were posted in the newsletter.

OLD BUSINESS: There was a brief discussion regarding the possibility of video cameras at the entrance. Many landowners expressed appreciation for the Christmas decorations and the general appearance of the community. Tim Brown reported that the new street lights should be installed within 2 months.

NEW BUSINESS: There was a suggestion to use the newsletter to persuade landowners to slow down on the streets (Paved and dirt). The priority list of projects was adopted from comments from landowners. Tim Brown explained that FPL trims trees near power lines only every 5 years but landowners should call if there is sparking. Being no further business the meeting was adjourned approximately 9 PM.
