After a shut-down beginning April 2020, the Palm Beach County Sheriff will soon be reactivating the COP program county wide. During this period Palm Beach Country Estates has lost more than 8 of the original volunteers for this program.

The new car has less than 3,000 miles and will be based at the Church of God and Prophecy Community Church located at 6641 Donald Ross Rd. 

